

Mother-in-law's tongue... corded mouths... the truth erased!



Mother-in-law's tongue... (literally translated from Dutch to English: Women's tongue).

My roots can't be denied because even now it's the plants that inspire me to transfer several of my thoughts into words.

Women's tongue... or the 'Sunday's name' is Sansevieria trifasciata.

A strong plant; the person who kills this plant deserves a medal!

Last week I had promised my begonias a larger pot. They want to stand outside and I have given in to their wish.

Nature cannot be forced, even when I wish otherwise.

Outside, in all freedom, they grow even better so it became necessary to give their feet more room.

We went to a garden center to get a bag of potting soil and two terracotta flower pots. I no longer want to plant them in plastic pots anymore; plastic isn't good for our environment. If we want to listen to nature we'd better do it right from the beginning!

While we were walking through the garden center I noticed a box containing a small variant of Sansevieria. Indeed, there are many sorts and variations and you won't believe what they had done to this one!



They first had the six leaves braided. A standing braid in a jar, the tops bound together. They were clearly marked as Sansevieria, but it really made you wonder why they had done so and how this could succeed. The experts know that these leaves are rather stiff and firm.



Amazing how nature was forced. Through a special technique probably, because these leaves are somewhat 'fleshy', unlike the 'old fashioned' Sansevieria.

My begonias started protesting after being a few days in the house because they simply prefer to stand outside now. What will these Sansevieria's go through?

Women's tongues and then tied together... it should not become crazier. This is called a gag!

Literally gagged!

Do we let that happen to us? I mean... being gagged? If we look at various events around us it often seems that way.

News, real news that may not be distributed, or is removed

from the Internet. That falls under the umbrella word... gagged! Get rid of it, don't talk about it, because if you keep quiet about things, they're not there!

People can do that so well: don't talk about it, act like an ostrich: stick your head into the sand and go on with your daily worries.

What you don't know doesn't hurt... another!

We, and many with us, feel that we just *do* want to know! On top of that: the information we have needs to be spread as widely as possible among the people!

The Foundation 'Stralingsarm Nederland' had that idea too and had sent a series of questions to Minister Klink (Ministry of Health, Wellbeing and Sports) regarding the H1N1-flu vaccine that was purchased on a large scale: for every Dutch citizen two copies were ordered
